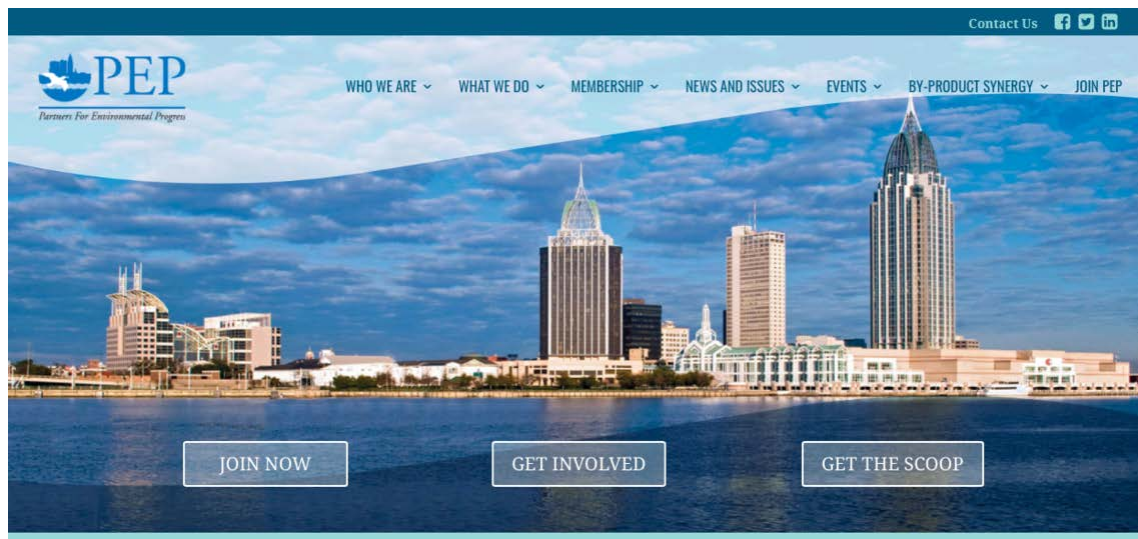
Creative Construction of a New Water Treatment Facility in Historic Neighborhood
