



# Environmental Stewardship Member Awards

## 2021 Nomination Application

Since 2005, the PEP Board of Directors has presented the PEP Environmental Stewardship Awards to recognize PEP members whose work has made a significant and positive contribution to the Gulf Coast region in three crucial areas: economic growth, environmental health and social responsibility.

The PEP Board of Directors is currently seeking applicants for the 2020 PEP Environmental Stewardship Member Awards. Nominations must be submitted by March 22, 2021.

### Eligibility:

- PEP member companies can self-nominate their company, a project partner or co-nominate with another partner on a multi-faceted project.
- The applicant and at least one significant project partner must be a PEP member.
- The project should be located in the Central Gulf Coast region and completed in the last 12-18 months.
- The project must demonstrate innovative environmental best practices in manufacturing, construction, engineering, conservation or restoration.
- Company-led service projects that result in environmental restoration or conservation are also eligible.

**Please note**, businesses of all sizes have won this award based on the project's innovation, not simply the overall size of the project's environmental impact.

### Presentation of Awards:

The awards will be presented at PEP's Annual Membership Meeting on a date to be determined. PEP publicizes all award winners to our local media and the community through online and print advertising. # SUBMITTING THE APPLICATION

## I. Complete the Official Application:

### Item 1.

- Provide the complete name of the company.
- Provide the name of the *person responsible for oversight of the project or activity being nominated*, such as the plant manager, CEO, Production Manager, EHS Manager, etc., and that person's complete mailing and email address and telephone number.
- Enter the name of the company's Chief Executive Officer, number of employees and industry or business type.
- Indicate the project's location if it is not the same as the address above.

**Item 2.** Provide the name, title, organizational affiliation, telephone number and complete mailing address of the *person submitting the application*. This may be the Marketing or Public Relations Director or any company employee. The applicant may be the same as the project contact person.

**Item 3. In 250 words or less**, provide a summary describing the project and its **overall significance and environmental impact and benefits**. (PEP will use this summary for the event brochure and press materials.) This is a required and important part of the application!

### Item 4. Attach a Narrative Statement:

This statement should provide even more detail than the summary in Item 3. This narrative statement should describe how the company's project or activity was located in the Central Gulf Coast region, completed within the previous 12-18 months and led to a significant environmental contribution.

### The narrative should include

- A short description of what the company does.
- The problem being addressed.
- A description of any innovative or unique approaches that were used.
- The environmental impact, both immediate and long-term.
- The project's measurable results, such as material diverted from disposal, cost savings, revenue generated, and

reduction in greenhouse gas emissions, etc.

- Any additional information explaining the beneficial impact on the community, such as jobs created. Will you be training others to replicate or share the innovation at other sites or in other applications?
- Project partners that should be recognized as part of the project's success.

**The narrative should be no more than two pages typed and double-spaced.** Jargon and technical explanations should be kept to a minimum and explained in laymen's terms as appropriate. Consider providing easy to understand comparable results: i.e., the amount of greenhouse gas reduced is equivalent to x # of cars.

## II. Sustainability Policy Statement:

**It is not required, but you may choose to include, in addition to the narrative**, a brief paragraph outlining the company's current best environmental practices and the company's sustainability mission or policy statement.

## III. Photograph Submissions:

All photographs submitted must include copyright permission. Submit photos by email as a JPEG or TIFF file at 300 dpi resolution or higher.
